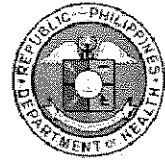

## INVITATION TO BID FOR

- The **NATIONAL CENTER FOR MENTAL HEALTH**, through the **GAA 2018** intends to apply the sum of **PHP 110,500,000.00** being the Approved Budget for the Contract (ABC) to payments under the contract for the following categories. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Prospective Bidders for **Infra. Project No. 01-2018 - Design and Build of Pavilion 2 (Rezoning, Repair / Rehabilitation)** and **Infra. Project No. 02-2018 - Repair / Rehabilitation of Pavilion 30** should have experience in undertaking similar projects within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Detailed Bid-Evaluation & Post-Qualification of the lowest-calculated bid shall be conducted.

- The **NATIONAL CENTER FOR MENTAL HEALTH** now invites bids for **Infra. Project No. 01-2018 - Design and Build of Pavilion 2 (Rezoning, Repair / Rehabilitation)** and **Infra. Project No. 02-2018 - Repair / Rehabilitation of Pavilion 30**. Delivery of the Goods is required as specified in the SCHEDULE OF REQUIREMENTS. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- Interested bidders may obtain further information from **NATIONAL CENTER FOR MENTAL HEALTH** and inspect the Bidding Documents at the address given below during office hours.
- A complete set of Bidding Documents may be acquired by interested Bidders on **April 18, 2018 (Monday to Friday 8:00AM – 4:00PM)** from the address below, upon submission of **LETTER OF INTENT** and payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of:

Project No. 01-2018 - Design and Build of Pavilion 2 (Rezoning, Repair / Rehabilitation)** and **Infra. Project No. 02-2018 - Repair / Rehabilitation of Pavilion 30** at **BAC CONFERENCE ROOM, PROCUREMENT SECTION OF NATIONAL CENTER FOR MENTAL HEALTH COMPOUND, MANDALUYONG CITY**, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **May 7, 2018: 9:00AM(Monday)** for **Infra. Project No. 01-2018 - Design and Build of Pavilion 2 (Rezoning, Repair / Rehabilitation)** and **Infra. Project No. 02-2018 - Repair / Rehabilitation of Pavilion 30**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.


