1. Two (2) units, latest model, fully-automated, integrated Clinical Chemistry analyzer based on Photometry and Immunology analyzer based on chemiluminescence with the following specifications:						
a. Floor type model with a throughput of at least 800 tests per hour for chemistry and 100 test/hour for immunology.						
b. Capable of testing for therapeutic drug monitoring and other substances of abuse.						
c. With direct ISE modules for serum, plasma and urine electrolytes determination.						
d. Capable of running other body fluids such as CSF, urine, pleural fluid, etc., using the same reagents for serum, or with provisions of reagents for other body fluids.						
e. Capable of detecting lipemic, hemolyzed and icteric samples without additional reagents to be used.						
f. Automatic reruns and dilution.						
g. Random access for STAT request.						
h. Equipped with programs for test counters, reagent inventory and quality control chart.

6. Provide 24 hours a day, 7 days a week technical support and aftersales support.
7. Free monthly check up and quarterly Preventive Maintenance and Calibration for both machines.
8. Free parts replacement for both machines in case of machine breakdown.
9. Provide for adequate storage of reagents based on quantity and storage temperature requirement. (Biological/pharmaceutical refrigerators and freezers)
10. Provide four (4) 1,000 uL fixed pipettors, four (4) 100 uL fixed pipettors, and four (4) fixed 50 uL pipettors with orbital rack, with free preventive maintenance and calibration conducted biannually.
