

# **SECTION I Invitation to Bid**

PUBLIC BIDDING FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF BRAND-NEW ELECTROMYOGRAPHY(EMG) FOR MOTOR THRESHOLD DETERMINATION FOR PAVILION 2 – TMS OFFICE CY 2024 IB No. E-011-2024-PB

- The National Center for Mental Health, through the HFEP CY 2024 intends to apply the sum of Three Million Five Hundred Twenty Thousand Pesos (Php 3,520,000.00) being the ABC to payments under the contract for Supply, Delivery, Installation, Testing and Commissioning of Brand-New Electromyography(EMG) for Motor Threshold Determination for Pavilion 2 TMS Office CY 2024 IB No. E-011-2024-PB. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **National Center for Mental Health** now invites bids for the above Procurement Project. Delivery of the Goods is required by 30 calendar days. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from the **Procurement Section** of the National Center for Mental Health and inspect the Bidding Documents at the address indicated on the next page during 8:00 AM to 5:00PM.
- A complete set of Bidding Documents may be acquired by interested Bidders June 6, 2024 June 25, 2024 Monday-Friday (8:00AM 5:00PM) from the given address and website(s) below, and upon submission of LETTER OF INTENT and payment of the applicable fee for the bidding documents, pursuant to the latest guidelines issued by the GPPB, in the amount of as indicated below. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through in person payment.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on June 26, 2024 (Wednesday) 9:00AM at the BAC Conference Room, NCMH Compound. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
