- f. Notice of Award or Notice to Proceed Issued by the owners, as attachment for the Single Largest Completed Contract (SLCC) within the past 2 years prior to the date of submission and receipt of bids.
- g. Certificate of Good Performance for Medical Equipment related projects [For current supplier, it shall be issued by the Head of the Procuring Entity for the current year. For non-current Contractor, certificate issued from other Hospitals or agencies are acceptable (at least SATISFACTORY RATING)].
- h. Notarized/CTC certificate of current and valid of authorized or exclusive distributorship.
- i. Notarized/CTC certificate of current and valid of Manufacturer's compliance with ISO 13485.
- j. Notarized certificate from the manufacturer or distributor stating that the equipment is brand new, unused and not a discontinued model or was listed in the market recall.
- k. Notarized/CTC bidder's certificate guaranteeing the availability on the supply of spare parts five (5) years from the end of production. A certification must be issued by the manufacturer for the bidder.
- 1. **Notarized** certification that the bidder must be in the local market for a minimum of ten (10) years.
- m. **Notarized** certification that the system or machine is not a retrofit solution
- n. Notarized manufacturer's approved US FDA Premarket Notification (PMN) or CE mark approval certificate. The machine should have a US FDA approval.
- o. **Notarized** certification that the supplier has the capability or authority for corrective and preventive maintenance of the unit. The certificate must be issued by the manufacturer to the bidder.
- p. Notarized certification from the manufacturer or distributor that the warranty should not be affected with change of distributorship
- q. **Notarized** Warranty Certification: Certification that the bidder/supplier shall provide a three (3) year warranty for parts and services that includes corrective maintenance, preventive maintenance, and/or calibration. The warranty shall commence upon the acceptance of the end-user
- r. Notarized certification that the bidder must provide preventive maintenance and/or calibration schedule within warranty period.
- s. **Notarized** certification that the supplier / bidder shall provide applications training for the users and maintenance personnel of the hospital.
- t. **Notarized** certification to provide manuals: Two (2) sets of service manual in English Language and Two (2) sets of user manual in English Language upon delivery of the equipment.
- u. Notarized certification that the brand has been in the local market for at least five (5) years with at least five (5) current installations.
- v. Notarized certification that the supplier will be responsible for the notification, transportation to the site, delivery, installation and testing on the site (hospital / health facility) expenses for such will be on the account of the supplier.
