Invitation to Bid

PUBLIC BIDDING FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF BRAND-NEW REPETITIVE TRANSCRANIAL MAGNETIC STIMULATOR WITH TWO CHANNEL EMG FOR AUTOMATIC MOTOR THRESHOLD DETERMINATION FOR THE USE OF AGED AND WELLNESS UNIT CY 2024

1. The **National Center for Mental Health**, through the **HFEP CY 2024** intends to apply the sum of **Twelve Million Pesos Only (Php 12,000,000.00)** being the ABC to payments under the contract for **Supply, Delivery, Installation, Testing and Commissioning of Brand-New Repetitive Transcranial Magnetic Stimulator with Two Channel EMG for Automatic Motor Threshold Determination for the Use of Aged and Wellness Unit CY 2024 / IB No. E-007-2024-PB**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **National Center for Mental Health** now invites bids for the above Procurement Project. Delivery of the Goods is required by **30 calendar days**. Bidders should have completed, within **2 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
