**PUBLIC BIDDING FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF VARIOUS BRAND-NEW EQUIPMENT FOR ERCI CY 2024**  
**IB No. E-014-2024-PB**

1. The **National Center for Mental Health**, through the **HFEP CY 2024 & INCOME 2024** intends to apply the sum of **Seven Million Eight Hundred Fifty-Two Thousand Five Hundred Forty-Nine Pesos and 84/100 Only (Php 7,852,549.84)** being the ABC to payments under the contract for **Supply, Delivery, Installation, Testing and Commissioning of Various Brand-New Equipment for ERCI CY 2024 / IB No. E-014-2024-PB**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **National Center for Mental Health** now invites bids for the above Procurement Project. Delivery of the Goods is required by **60 calendar days**. Bidders should have completed, within **2 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the **Procurement Section of the National Center for Mental Health** and inspect the Bidding Documents at the address indicated on the next page during **8:00 AM to 5:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **July 9, 2024 – July 26, 2024 (Monday to Friday, 8:00AM to 5:00PM)** from the given address and website(s) below, and upon submission of **LETTER OF INTENT** and payment of the applicable fee for the bidding documents, pursuant to the latest guidelines issued by the GPPB, in the amount of as indicated below. The Procuring Entity shall allow the bidder to present its proof of payment for the fees through in person payment.
