CONTRACT AGREEMENT

 - 2. Technical Specifications;
 - 3. General and Special Conditions of Contract; and
 - 4. Supplemental or Bid Bulletin, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract</u> <u>documents or information prescribed by the GPPB that are subsequently re-</u> <u>quired for submission after the contract execution, such as the Notice to Proceed</u> <u>and Warranty Security, shall likewise form part of the Contract.</u>
