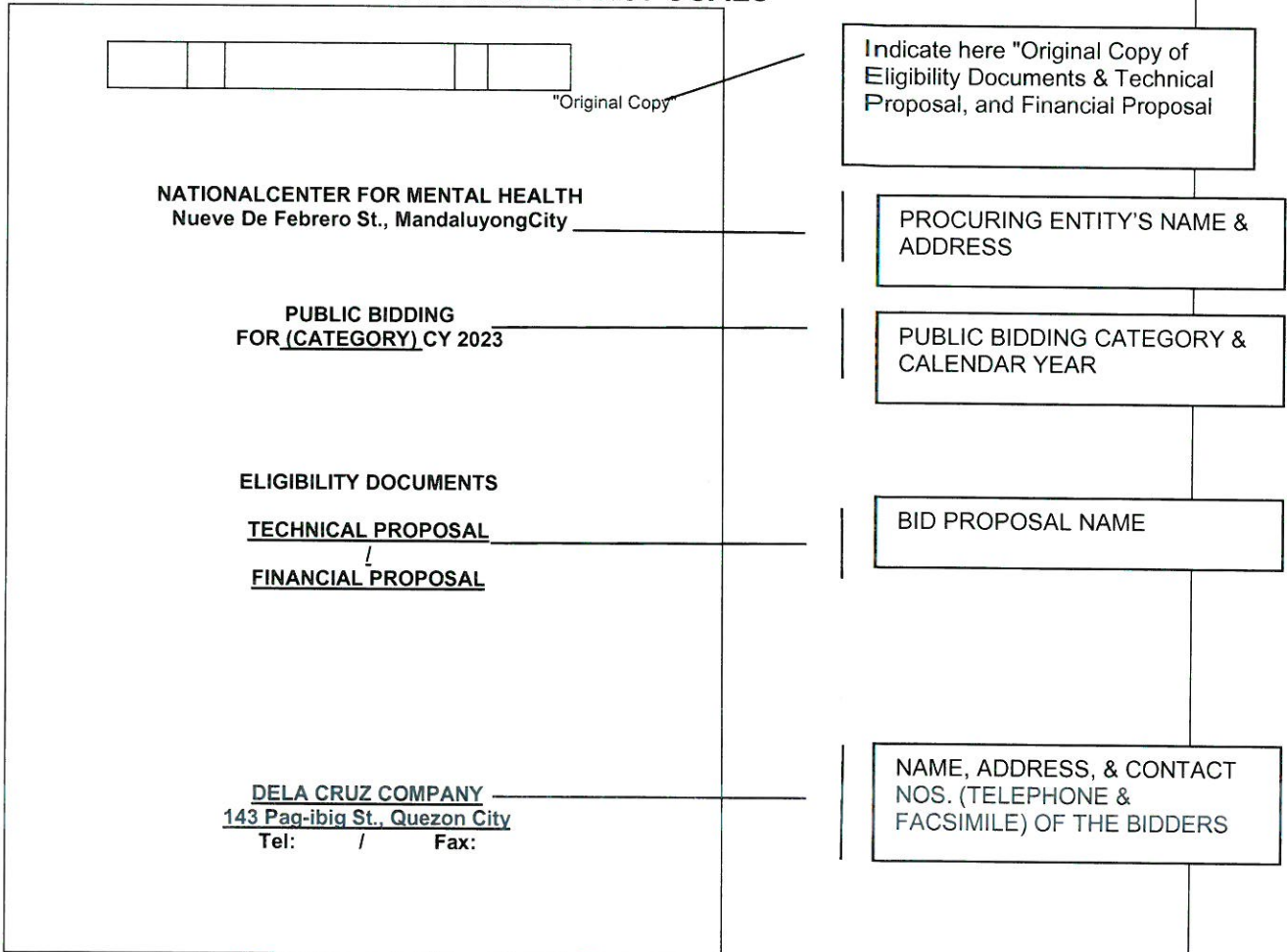

Certificate Good Performance from at least three (3) tertiary hospital stating the name of facility, address, type of equipment and its model, and the date of delivery must be provided [For current service provider, it shall be issued by the Head of Procuring Entity / Medical Center Chief II of NCMH, for the current year. For non-current service provider, certificate issued from other Hospitals or agencies are acceptable (at least SATISFACTORY RATING)]. f. Certification that the bidder/supplier shall provide three (3) years warranty for parts and services with free quarterly preventive maintenance after end user acceptance. Warranty shall commence upon the acceptance of the end user. The winning bidder shall issue a certificate reflecting the duration of warranty period. g. Bidder's certificate guaranteeing the availability on the supply of spare parts ten (10) years from end of production. A certification must be issued by the manufacturer for the bidder h. The bidder shall provide the manufacturer's approved US FDA Premarket Notification (PMN) or 510(k) certificate or CE Mark Approval certificate. n. Certification that the supplier has the capability for corrective and preventive maintenance of the unit. The certificate must be issued by the manufacturer for the bidder. o. Certification from the manufacturer authenticated by the Philippine consulate from the country of origin of the unit that the warranty should not be affected with a change of distributor. p. Certification that the brand and model must be in the local market for a minimum of five (5) years with at least five (5) Full digital Xray of the same brand in tertiary government facilities (at least one (1) must be DOH hospitals) q. 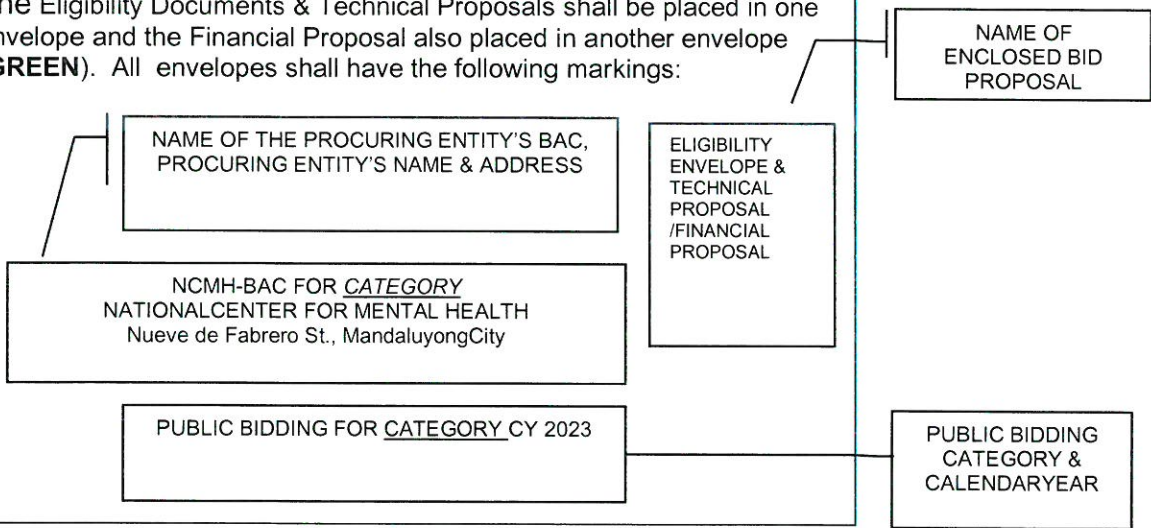
