1. The *National Center for Mental Health*, through the FY 2025 *National Expenditure Program (NEP)* intends to apply the sum of **Php 2,133,175.00** being the ABC to payments under the contract for the EPA for the “**Public Bidding for the Supply and Delivery of Radiology Supplies FY 2025 (Early Procurement Activity)**”. Bids received in excess of the ABC shall be automatically rejected at bid opening.


2. The *National Center for Mental Health* now invites bids for the above Procurement Project. Delivery of the Goods is required by (**See Schedule of Requirements**). Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **Procurement Section of the National Center for Mental Health** and inspect the Bidding Documents at the address given below during **8:00am to 5:00pm**.
5. A complete set of Bidding Documents may be acquired by interested Bidders **October 9, 2024 – October 28, 2024 (Monday to Friday, 8:00AM – 5:00PM)** from the given address and website(s) below and upon submission of **LETTER OF INTENT** and payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of:

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The *National Center for Mental Health* will hold a Pre-Bid Conference on **October 17, 2024, 9:00AM (Thursday) at BAC Conference Room of National Center for Mental Health**, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office indicated below. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **October 29, 2024 (Tuesday) 9:00AM at the BAC Conference of the National Center for Mental Health**. Bids will be opened in the presence of bidders' representatives who choose to attend the activity.
