## Public Re-Bidding for the Supply and Delivery of Medical Supplies CY 2024

The *National Center for Mental Health*, through the *GAA CY 2024* intends to apply the sum of *Php9,140,472.24* being the ABC to payments under the contract for the following categories. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The *National Center for Mental Health* now invites bids for the above Procurement Project. Delivery of the Goods is required by (See Schedule of Requirements). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "passifail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from **Procurement Section of the National Center for Mental Health** and inspect the Bidding Documents at the address given below during 8:00am to 5:00pm.
- 5.
