



INVITATION FOR NEGOTIATED PROCUREMENT – TWO FAILED BIDDING

In view of the two (2) failed public biddings conducted for the project **Laundry Outsourcing (Wash and Dry) CY 2019 and Supply and Delivery of Carpentry Supplies (Lot) CY 2019**, the National Center for Mental Health, intends to negotiate, in accordance with Section 53.1 of the Revised Implementing Rules and Regulation of Republic Act (R.A) No. 9184 (Government Procurement Reform Act) the total sum of **Eleven Million Three Hundred Thirteen Thousand Twenty Five Pesos and 13/100 Only. (Php 11,313,025.13)** broken down as follows:

being the Approved Budget for the Contract (ABC) to payments under the contract for Negotiated Procurement of **LAUNDRY OUTSOURCING (Wash and Dry) CY 2019 and Supply and Delivery of Carpentry Supplies (Lot) CY 2019**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The National Center for Mental Health now invites Offers/Proposals for the said project. The delivery of the Goods/Services is required as specified in the **SCHEDULE OF DELIVERY**. Bidders should have completed, within Two (2) years from the date of submission and receipt of bids, a contract similar to the Project.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to the Filipino citizens, pursuant to RA 5183.

The National Center for Mental Health will hold a **Negotiation Conference on February 20, 2019, Wednesday, 1:30 PM, at BAC Conference Room, Procurement Section of National Center for Mental Health, Nueve de Pebrero St., Barangay Mauway, Mandaluyong City** which shall be open to prospective bidders.

A complete set of Bidding Documents may be acquired by interested Bidders on **February 18 to March 4, 2019, 8:00 AM to 5:00 PM**, from the address below

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity.


Interested Bidders shall submit the documents (Eligibility, Technical and Financial Proposal) in three (3) copies, labeled as Original Copy, Copy 1 and Copy 2. Each folder shall be properly labeled with Table of Contents according to the checklist to bidders issued.

Offers/Proposals must be duly received by the BAC Secretariat at the address below on or before **March 5, 2019, Tuesday, 1:30 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Opening of offers/proposals shall be on **March 5, 2019, Tuesday, 1:30 PM**, at **BAC Conference Room, Procurement Section of National Center for Mental Health, Nueve de Pebrero St., Barangay Mauway Mandaluyong City**, in the presence of the bidder's representatives who chose to attend at the address. Late bid shall not be accepted.


The NCMH reserves the right to reject any and all bids, declare failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
