- GENERAL
- GENERAL NOTES AND TYPICAL STRUCTURAL DETAILS SHALL APPLY TO ALL DRAWINGS
  - CONCRETE
  - CONCRETE SHALL BE CAST AND CURED ACCORDING TO THE FOLLOWING PROVISIONS:
    - 1.1 UNLESS OTHERWISE SPECIFIED OR NOTED
    - 1.2 FINISH OF CONCRETE SHALL BE TYPICAL AND SHALL APPLY GENERALLY TO ALL EXPOSED SURFACES UNLESS OTHERWISE SPECIFIED
    - 1.3 THE CONTRACTOR SHALL EXAMINE THE DRAWINGS AND SHALL NOTIFY THE ARCHITECT IMMEDIATELY IN WRITING OF ANY DISCREPANCIES HE MAY FIND BEFORE PROCEEDING TO THE WORK

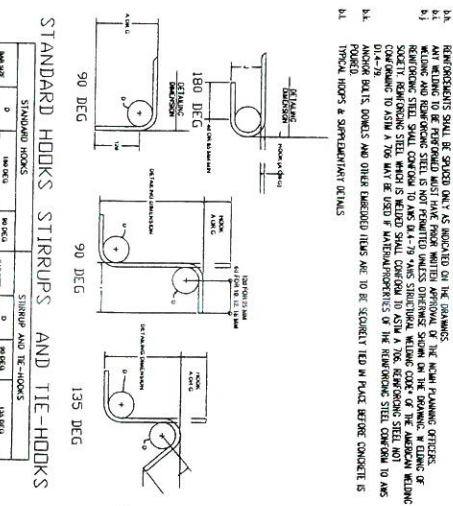

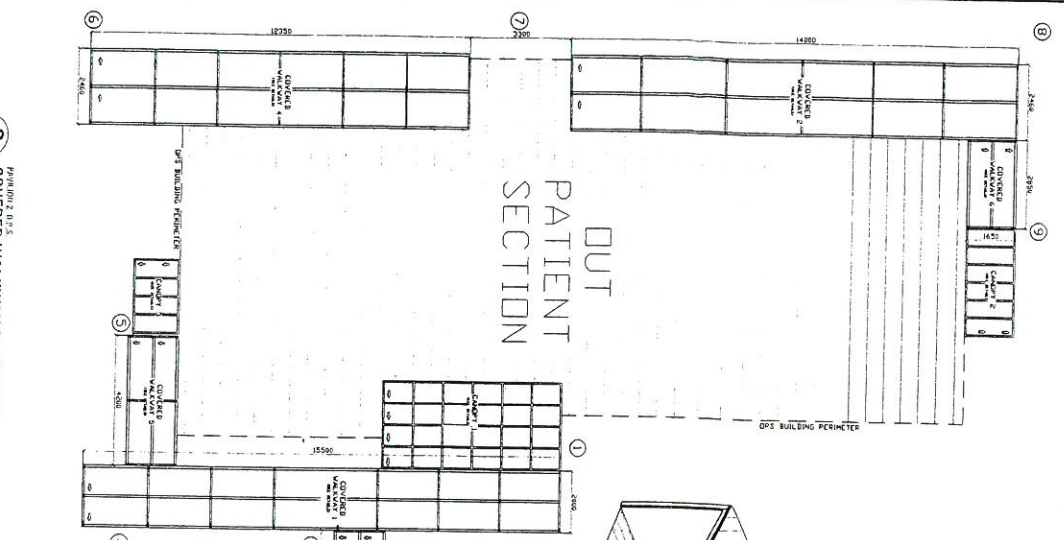


FIGURE 2.02.6

204 1/1.55 MTS.

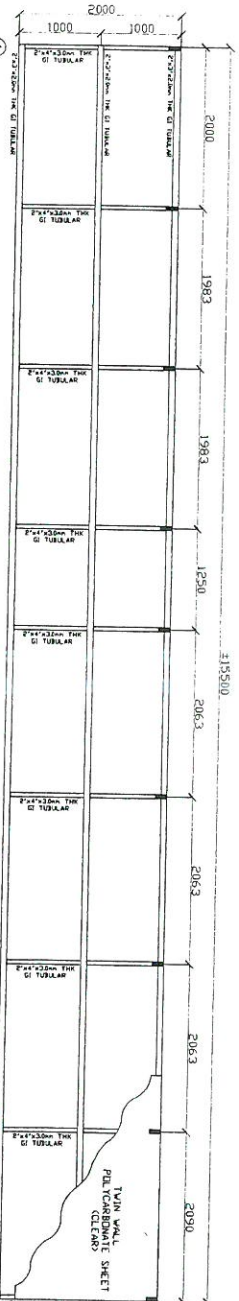


FIGURE 2.02.7

202 1/1.25 MTS.

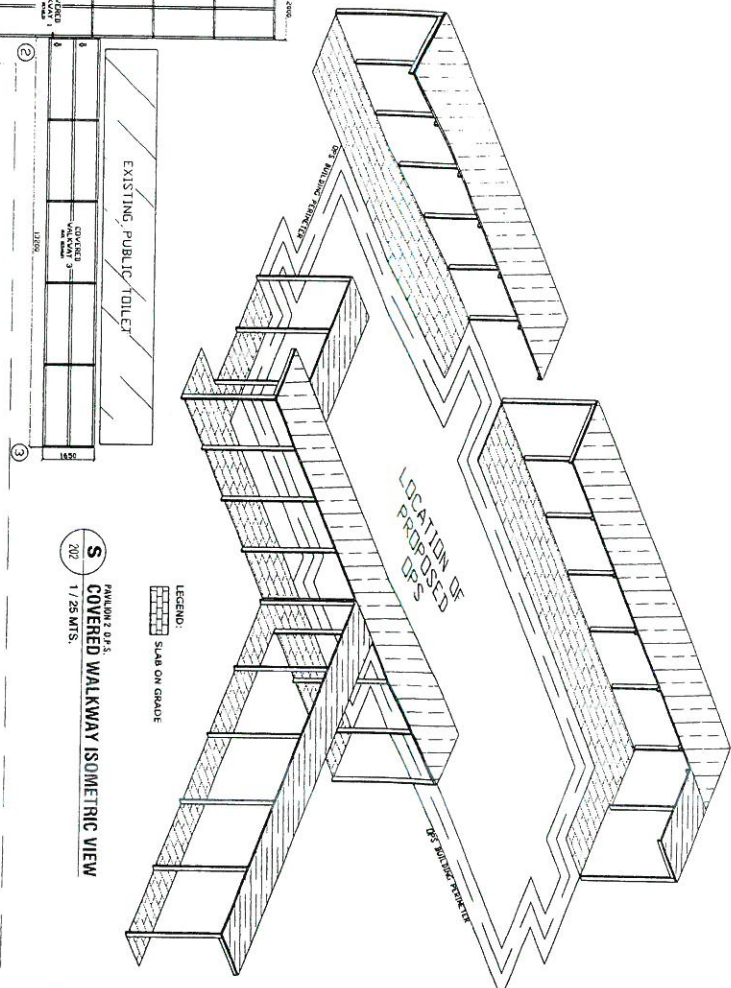
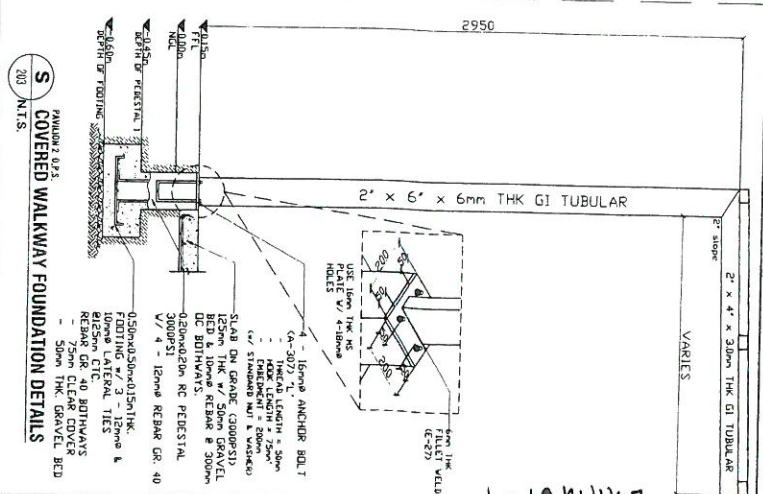


FIGURE 2.02.8
