PROPOSED GROUND FLOOR PLAN



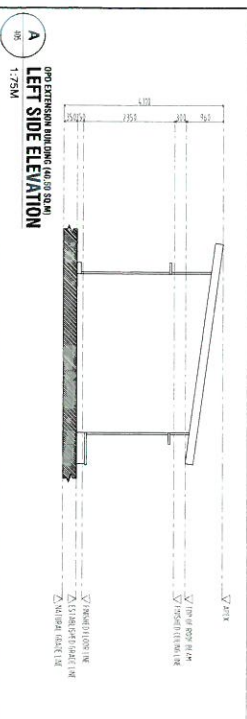

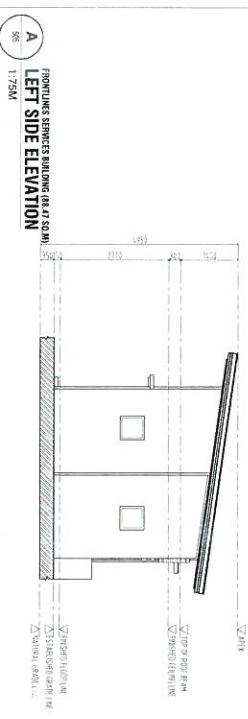

DETAILED TOILET PLAN



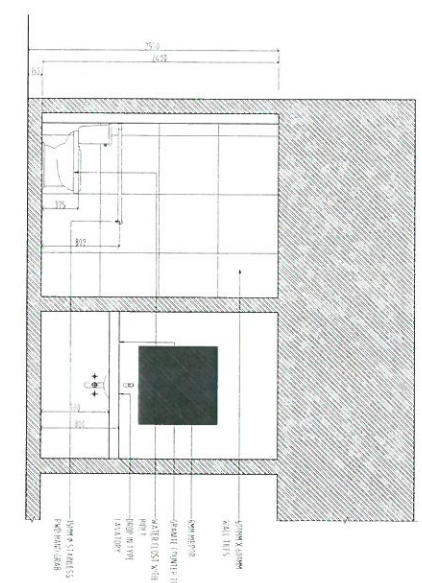

GENERAL

- GENERAL NOTES AND TYPICAL STRUCTURAL DETAILS SHALL APPLY TO ALL DRAWINGS.
- FEELINGS OF RESPONSIBILITY OR NOTICE SHALL APPLY TO ALL DRAWINGS THROUGHOUT FOR SIMILAR CONDITIONS. MODIFY TYPICAL DETAILS AS REQUIRED TO MEET SPECIAL CONDITIONS.
- THE CONTRACTORS SHALL EXAMINE THE DRAWINGS AND SHALL NOTIFY THE ARCHITECT IMMEDIATELY OF ANY DISCREPANCIES HE MAY FIND BEFORE PROCEEDING TO THE WORK.
- IT SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO PROVIDE ADEQUATE SHORING AND BRACING FOR THE STRUCTURE FOR ALL LOADS THAT MAY BE IMPOSED DURING CONSTRUCTION.
- ALL MATERIALS AND WORKMANSHIP SHALL CONFORM TO THE LATEST APPLICABLE STANDARD OR SPECIFICATION. ALL WORKS SHALL CONFORM WITH THE BEST PRACTICES AND METHODS IN THE INDUSTRY THAT ARE SUBJECT TO INSPECTION AND TESTING BY THE ENGINEER/ARCHITECT.
- EXAMINATION AND TESTING BY THE ENGINEER/ARCHITECT SHALL BE THE CONTRACTOR'S RESPONSIBILITY. THE CONTRACTOR SHALL FOLLOW TYPICAL DETAILS AS SHOWN IN THESE DRAWINGS.
- THE CONTRACTOR WILL BE RESPONSIBLE FOR THE COORDINATION OF WORK AMONG VARIOUS TRADES AS NECESSARY TO AVOID CONFLICTS AND TO ENSURE THE INSTALLATION OF ALL WORKS WITHIN AVAILABLE SPACE.
- DO NOT SCALE DRAWINGS OR CALLED OUT DIMENSIONS. STANDARD CODE REQUIREMENTS SHALL GOVERN OVER UNSCALED DRAWINGS.
- SPECIAL NOTES AND DIMENSIONS INDICATED ON THE STRUCTURAL DRAWING SHALL BE COORDINATED WITH THE ARCHITECTURAL DRAWINGS, ARCHITECTURAL STOREYS SHALL BE USED TO DETERMINE DETAIL CONGRUITY, ELEVATIONS, OPENINGS, JOINTS, STAGES, ETC.
- 11.1 MODIFICATION OF SECTION AND SIZE OF STRUCTURAL MEMBERS SHALL NOT BE PERMITTED WITHOUT THE WRITTEN APPROVAL OF THE ENGINEER/ARCHITECT.
- 11.2 CONTRACTOR TO PROVIDE REINBAR/ALTERNATIVE TENSILE STRENGTHS. THESE TESTINGS SHALL BE CONDUCTED BY ACCREDITED AGENCY.
- 11.3 IN CASE OF STRUCTURAL MEMBERS SPECIFIED ARE NOT AVAILABLE, SUBMIT TO CLIENT ENGINEER AVAILABLE LIST OF MEMBERS FOR APPROVAL BEFORE PURCHASING.

 - a. REINFORCING STEEL SHALL CONFORM TO LATEST EDITIONS OF ASTM A615 GRADE 60 (F60200) AND ASTM A615 GRADE 40 (F40200). FOR 12MM DIA. BARS AND SMALLER WITH MINIMUM YIELD STRENGTH $f_y = 276MPa$ (4000 PSI).
 - b. ALL REINFORCING BARS SHALL BE DEFENDED BARS UNLESS OTHERWISE SPECIFIED IN THE DRAWINGS.
 - c. ALL REINFORCING BARS SHALL BE CLEAN OR RUST, GREASE OR OTHER MATERIALS LIKELY TO AFFECT BONDING. BARS SHALL ACCURATELY AND SECURELY PLACED BEFORE POURING OF CONCRETE OR APPLYING OF MORTAR OR GROUT.
