- k. Certification that the bidder/supplier shall provide three (3) years warranty period on all delivered goods and shall take effect immediately after final acceptance of the project with NCMH.
- Certification that the bidder/supplier shall provide product upgrades (hardware firmware or software upgrades) without additional cost to NCMH.
- m. Certification that the bidder/supplier shall provide an immediate RMA or backup unit at any time the HCl equipment is not working or under repair
- n. Certificate of end-user/technical staff acceptance statement relative to the installed base of their Hyper-Converged Infrastructure solution including authority for TWG to visit the site if locally installed.
- o. List of authorized Customer support/service centers near Mandaluyong City. The list must indicate the complete and existing business address, telephone and fax number/s, email address, and complete name of the contact person

- r. Certification that the supplier shall issue a Warranty Certificate of three (3) years on parts and services upon delivery, inspection, and acceptance as well as one basis for payment
