The National Center for Mental Health, through the INCOME CY 2024 intends to apply the sum of Seventeen Million One Hundred Twenty-One Thousand Two Hundred Fifty Pesos Only (Php 17,121,250.00) being the ABC to payments under the contract for the following category. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The National Center for Mental Health now invites bids for the above Procurement Project. Delivery of the Goods is required by (See Schedule of Requirements). Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from Procurement Section of the National Center for Mental Health and inspect the Bidding Documents at the address given below during 8:00am to 5:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders September 05, 2024 September 24, 2024 (Monday to Friday, 8:00AM 4:00PM) from the given address and website(s) below and upon submission of <u>LETTER OF INTENT</u> and payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of:

- 9. Bid opening shall be on September 25, 2024 (Wednesday), 9:00AM at the BAC Conference Room of National Center for Mental Health. Bids will be opened in the presence of bidders' representatives who choose to attend the activity.
