INVITATION TO BID

- The **NATIONAL CENTER FOR MENTAL HEALTH**, through the **GAA 2019** intends to apply the sum of **₱39,786,572.70 (for Supplies and Drugs)** and **HOSPITAL INCOME** for the sum of **₱19,351,432.00 (for Equipment)** being the Approved Budget for the Contract (ABC) to payments under the contract for the following categories. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Prospective Bidders for the above mentioned category should have experience in undertaking similar projects within the last two (2) years with an amount of at least 25% for the supplies and drugs of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Detailed Bid-Evaluation & Post-Qualification of the lowest-calculated bid shall be conducted, and;

- The **NATIONAL CENTER FOR MENTAL HEALTH** now invites bids for **CY2019**. Delivery of the Goods is required as specified in the **SCHEDULE OF REQUIREMENTS**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Bids must be duly received by the BAC Secretariat at the address below on or before **July 16, 2019, 9:00AM (Tuesday) for Drugs and Medicines and Supplies** and **July 17, 2019, 9:00AM (Wednesday) for Equipment**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **July 16, 2019, 9:00AM (Tuesday) for Drugs and Medicines and Supplies** and **July 17, 2019, 9:00AM (Wednesday) for Equipment** at the **BAC CONFERENCE ROOM, PROCUREMENT SECTION OF NATIONAL CENTER FOR MENTAL HEALTH COMPOUND, MANDALUYONG CITY**. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address below. **Late bids shall not be accepted.**

The **NATIONAL CENTER FOR MENTAL HEALTH** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
