'Items number 1-33 under LOT BIDDING; winning bidder shall provide two (2) units of the latest model of fully-automated Clinical Chemistry analyzer capable of testing Therapeutic Drug Monitoring (TDM) with free controls, calibrators and other consumables. It should be compatible with existing LIS and shall shoulder the interconnectivity fee of P 300,000

# ADDITIONAL TECHNICAL SPECIFICATION FOR CLINICAL CHEMISTRY REAGENTS UNDER REAGENT TIE-UP

ITEM CODE CS23 - 01 (Item No. 1 to 33)

'Items number 1-33 under LOT BIDDING; winning bidder shall provide two (2) units of the latest model of fully-automated Clinical Chemistry analyzer capable of testing Therapeutic Drug Monitoring (TDM) with free controls, calibrators and other consumables. It should be compatible with existing LIS and shall shoulder the interconnectivity fee of P 300,000 for new machine and P150,000.00 for recurring machine, to be paid to the hospital.

#### Machine specification:

- 1. Throughput of at least 800 test/hour and capable of running large volume of samples and has a random access for reagents and STAT samples.
- 2. With direct ISE modules for electrolytes serum, plasma and urine.
- 3. Capable of auto reruns and automated pre and post-dilution.
- 4. Equipped with program for test counters, reagent inventory and quality control graphs (LJ graphs and westgard rules)
- 5. Capable of detecting bubbles, clot correction, fluid level sensing, and short sample detection.
- 6. Shall provide and supply any water requirement for the machine for its operation, if needed, water

consumption should be less than 10 liter/hr.
(connecting to hospital water supply is not allowed)

- 7. Machine uses disposable tips and cuvettes.
- 8. Reagents must be ready to use and should not require manual reconstitution or mixing.
- 9. Must have a 24/7 help desk support system.
- 10. Winning bidder shall also provide a computer system compatible to the machine having the following specifications:
  - Running on a latest Microsoft Windows Platform (Windows 10 or latest whenever available)
  - Minimum microprocessor specification of Intel i5 11th generation or its equivalent
  - Minimum of 8gb ram
  - 1 TB HDD capacity
  - With installed software capable of word processing
  - Must come with AVR, UPS, and inkjet printer system
  - With a set local interface system for reproduction and digital storage of results and connected to the Hospital Information System.
- 11. The winning bidder must be able to provide a demo unit with complete reagents during post-qualification evaluation.
- 12. Must provide a cooling system for optimal equipment functionality.
- 13. The winning bidder must provide a biological refrigerator or freezer for storage of all the reagents and other consumables.

#### Other Matters:

- A. Eligibility requirements and technical proposal should be in one folder and financial proposal in a separate folder, with <a href="mailto:shoelace">shoelace</a> on top or ring bound instead of a fastener, <a href="mailto:table-of-contents">table of contents</a>, and index tabs in words, not numbers.
- B. Folder of Eligibility requirements and technical proposal should be placed in one envelope. And the folder of the Financial proposal should be in another envelope. Both envelopes shall then be placed in one mother envelope marked as "Original Bid"
- C. Documents should be arranged chronologically according to the checklist issued.

- E. All other provisions on the bidding documents which are not affected shall remain in effect.
- F. The deadline for **Submission and Opening of Bids** is scheduled on **November 04, 2022 (Friday), 9:00**<u>AM</u>, at the <u>PAG-ASA HALL</u>, National Center for Mental Health Compound, Mandaluyong City.
- G. Any bid submitted after the deadline for submission shall be declared "LATE" and shall NOT be accepted.
- H. The BAC shall open the bids immediately after the deadline for submission and receipt of bids.
