Additional Questions:

- 1) Can we make an offer if the item that you are looking for does not have the same specification in the Checklist?
- 2) Can we request additional Delivery days?

Answer:

- 1) Stick with the item specification.
- 2) The request for additional Delivery days will be after the receipt of the Notice to Deliver (NTD). The items awarded are not One-Time Delivery, it will depend on the End-User's request.

3) On the "Similar in Nature", can the ELECTRICAL SUPPLIES be the title on the Similar?

3) Yes.

4) Since there are electrical supplies under constructions supplies, can we use our contract for electrical supplies in materials for construction supplies?

4) Yes.

Other Matters:

- A. Eligibility requirements and technical proposal should be in one folder and financial proposal in a separate folder, with shoelace on top or ring bound instead of a fastener, table of contents, and index tabs in words, not numbers.
- B. Folder of Eligibility requirements and technical proposal should be placed in one envelope. And the folder of the Financial proposal should be in another envelope. Both envelopes shall then be placed in one mother envelope marked as "Original Bid"
- C. Documents should be arranged chronologically according to the checklist issued.
- D. Color code for folders and envelope:
 RED PUBLIC BIDDING FOR SUPPLY AND DELIVERY OF ELECTRICAL AND WELDING SUPPLIES
 CY 2023 (LOT)
- E. All other provisions on the bidding documents which are not affected shall remain in effect.
- F. The deadline for **Submission and Opening of Bids** is scheduled on **December 13, 2022 (Tuesday),** 9:00 AM, at the PAG-ASA HALL, National Center for Mental Health Compound, Mandaluyong City.
- G. Any bid submitted after the deadline for submission shall be declared "LATE" and shall NOT be accepted.
- H. The BAC shall open the bids immediately after the deadline for submission and receipt of bids.
