- C. For the Lowest Calculated Bidder, as part of Post Qualification Process, Equipment Demonstration or Site Installation Visit **if applicable**, or if unit is not available, Power Point or Online Presentation is **acceptable**.
- D. Certificate of Trained Engineer issued by the manufacturer.

- E. Certificate of Satisfactory Performance issued by the installed base hospital of the same brand being offered, **if applicable**.
- F. Documents should be arranged chronologically according to the checklist issued.
- G. Typographical error is not acceptable.
- H. Color code for folders and envelopes:
