- C. Eligibility requirements and technical proposal should be in one folder and financial proposal in a separate folder, with shoelace on top or ring binded instead of fastener, table of contents and index tabs in words, not numbers.

- D. Folder of Eligibility requirements and technical proposal should be placed in one envelope. And folder of financial proposal should be in another envelope. Both envelopes shall then be placed in one mother envelope marked as “**Original Bid**”.
- E. Documents should be arranged chronologically according to the checklist issued.
- F. Color code for folders and envelopes:

- G. All other provisions on the bidding documents which are not affected shall remain in effect.
- H. The deadline for **Submission and Opening of Bids** is scheduled on **October 25, 2022, 9:00 AM, Tuesday** at the **ADMIN. CONFERENCE ROOM**, National Center for Mental Health Compound, Mandaluyong City.
