ATTACHMENTS FOR PROJECT REQUIREMENTS

- Construction and Manpower Schedule is not required during Submission and Opening of Bids.
- All suppliers/bidders are required to submit their Detailed Unit Price Analysis (DUPA). Same presentation with the bidding documents.
- Soft copy of the floor plan will only be given to the LOWEST CALCULATED BIDDER/S.

Other Matters:

- A. *Eligibility requirements and technical proposal* should be in *one folder* and *financial proposal* in a *separate folder*, with <u>shoelace</u> on top or <u>ring binded</u> instead of fastener, <u>table of contents and index</u> tabs in words, not numbers.
- B. Folder of Eligibility requirements and technical proposal should be placed in one envelope. And folder of Financial proposal should be in another envelope. Both envelopes shall then be placed in one mother envelope marked as "Original Bid".
- C. Documents should be arranged chronologically according to the checklist issued.
- D. Color code for folders and envelopes:
