1. The winning bidder shall be given seven (7) government working days from receipt of the Notice to Proceed, to pick-up and haul the property;	1. The winning bidder shall be given FIFTEEN (15) WORKING DAYS (June 13, 2023 to July 3, 2023) from receipt of the Notice to Proceed, to pick-up and haul the property;

Other Matters:

- A. The Instruction to Bidders, Part I: Proposal Form and Part II: General Terms and Condition should be submitted affixing your signature and complete details.
- B. Eligibility requirement, financial proposal and the 10% Bid bond in the form of cash/managers check should be placed in the sealed envelope separately.
- C. All three (3) envelopes shall then be placed in one mother envelope marked as "Original Bid"
