Pick-up/Hauling of the Property by the Winning Bidder</b></p> <p>1. The winning bidder shall be given <b>FIFTEEN (15) WORKING DAYS (June 13, 2023 to July 3, 2023)</b> from receipt of the Notice to Proceed, to pick-up and haul the property;</p>

**Other Matters:**

- A. The Instruction to Bidders, Part I: Proposal Form and Part II: General Terms and Condition should be submitted affixing your signature and complete details.
- B. *Eligibility requirement, financial proposal and the 10% Bid bond in the form of cash/managers check should be placed in the sealed envelope separately.*
- C. *All three (3) envelopes shall then be placed in one mother envelope marked as "Original Bid"*
