### VII. TECHNICAL SPECIFICATIONS

### NOTE:

- Upgrade and configuration of virtual networks are included in the scope of works;
- The application is in-house built:
- Training must be certified by the Manufacturer; and
- Face to face training is required.

### Other Matters:

- A. Eligibility requirements and technical proposal should be in one folder and financial proposal in a separate folder, with <a href="mailto:shoelace">shoelace</a> on top or <a href="mailto:ring bound">ring bound</a> instead of fastener, <a href="mailto:table of contents">table of contents and index tabs in words, not numbers.
- B. Folder of Eligibility requirements and technical proposal should be placed in one envelope. And folder of financial proposal should be in another envelope. Both envelopes shall then be placed in one mother envelope marked as "Original Bid".
- C. Documents should be arranged chronologically according to the checklist issued.
- D. Color code for folders and envelopes:
  - WHITE
