Other Matters:

- A. Eligibility requirements and technical proposal should be in one folder and financial proposal in a separate folder, with shoelace on top or ring binded instead of fastener, table of contents and index tabs in words, not numbers.
- B. Folder of Eligibility requirements and technical proposal should be placed in one envelope. And folder of financial proposal should be in another envelope. Both envelopes shall then be placed in one mother envelope marked as **“Original Bid”**.
- C. Documents should be arranged chronologically according to the checklist issued.
- D. Typographical error must be countersigned by the authorized representative.
- E. Color code for folders and envelopes:
 - **ORANGE**
- F. All other provisions on the bidding documents which are not affected shall remain in effect.
- G. The deadline for **Submission and Opening of Bids** is scheduled on **November 14, 2023, 9:00 AM, Tuesday** at the **BAC Conference Room**, National Center for Mental Health Compound, Mandaluyong City.
- H. Any bid submitted after the deadline for submission shall be declared **“LATE”** and shall **NOT** be accepted.
- I. The BAC shall open the bids immediately after the deadline for submission and receipt of bids
